**SUBJECT:** Historic Wins for Educational Choice

#### **SUMMARY**

Tuesday's election was a historic success for the educational choice movement. With only a few exceptions, AFC-supported candidates won in convincing fashion in the vast majority of our target states, and opportunities to win additional seats materialized in places we had not previously imagined upon entering the election cycle or even on Election Day.

The election results present an opportunity to advance bold school choice proposals in several new states and/or to expand existing programs to help significantly more children access a better education.

We believe there are opportunities to pass or improve public charter and/or private school choice legislation immediately in new states like Missouri, Kentucky, Iowa and New Hampshire; and in current AFC target states of Arizona, Georgia Tennessee, Texas, Oklahoma, Ohio and Wisconsin. Other states present opportunities as well but will require a deeper analysis over the next several weeks.

Overall, AFC, the AFC Action Fund (527) and its affiliated state political committees spent just shy of \$5 million on election-related activities in 2016, split nearly evenly between the primary and general elections. Despite massive spending by the teachers' unions, a divisive political climate, and political trends that seemingly favored our opponents, AFC won 108 races and only 13 losses for the general election. In other words, in the general election, we won 89% of our targeted races.

AFC's state team focused our resources on the most genuinely competitive seats, developing professional and impactful political plans that truly made a decisive difference in many of these races. AFC's state teams were skillful at cultivating and evaluating candidates.

While AFC does not engage in federal elections, we are encouraged by the incoming Trump-Pence Administration pro-school choice positions and the congressional majority led by Speaker Paul Ryan and Senate Majority Leader Mitch McConnell. Three pro-school choice Democrats will join the ranks of the U.S. House of Representatives, former Democratic state legislator Al Lawson (FL), State Sen. Darren Soto (FL) and State Rep. Dwight Evans (PA). We believe all of this holds exciting promise for not only reauthorizing and growing the D.C. Opportunity Scholarship Program but also for broader and bolder initiatives to leverage federal money in ways that will complement what states are already doing to create more and better educational options for children.

# **State-by-State Results for Educational Choice**

#### **Arizona**

AFC fought successfully to maintain the school choice majority in the Arizona Senate despite well-funded opposition. We increased the school choice majority in the state House, where we hope to pass a robust expansion of the state's Education Savings Account (ESA) program with the help of Governor Doug Ducey (R), a choice supporter, and provide equitable funding for charter and choice schools.

#### Florida

In what was a phenomenally successful election for educational choice in Florida, candidates backed by our Florida affiliate, the Florida Federation for Children (FFC), won 20 of 21 races, nearly all of which were highly competitive. Despite a union-backed legislative redistricting effort meant to roll back bipartisan school choice majorities, those majorities were instead strengthened.

Following the successful effort in Florida's August primary, Tuesday's general election highlight was the defeat of the teachers' union biggest ally and our biggest foe in the legislature in a South

Florida state Senate seat. The union spent over \$1 million to re-elect state Senator Dwight Bullard (D), an amount nearly equal to the entire FFC election budget for the state. Their efforts fell short, as Representative Frank Artiles (R) won this majority-Democratic district in Miami-Dade County, a stunning upset and a huge victory for educational choice.

Several of these victories in legislative seats across Florida were due in part to television advertising that featured scholarship parents holding opponents accountable, and a brilliant ground game in which scholarship parents made tens of thousands of phone calls and knocked on voters' doors in key races. These are the same low-income families the ongoing teachers' union lawsuit seeks to evict from the state's tax credit scholarship program.

#### Georgia

With a limited number of competitive general election opportunities for legislative seats, our affiliated Georgia political operation built on its success earlier this year in state legislative primary races by defending our biggest ally in the state Senate and adding school choice supporters in the state House of Representatives.

Gov. Nathan Deal's ballot measure to create an "Opportunity School District" that would allow the state to take over or shut down failing schools and convert them to charters, known as Amendment 1, was rejected by a 60-40% margin. The teachers' union spent millions to defeat the measure.

#### Indiana

Indiana elections produced tremendous success for the educational choice movement in a crucial state. Lieutenant Governor Eric Holcomb (R), who trailed in many polls in the weeks leading up to the election, scored a surprisingly strong victory in the open seat race to replace Governor Mike Pence. Having served as a key advisor to former Governor Mitch Daniels during the initial enactment of Indiana's education reforms five years ago, Holcomb is a true school choice champion, advocating strongly and frequently for parents during his campaign.

We were also thrilled to see challenger Jennifer McCormick (R) oust State Education Superintendent Glenda Ritz (D) by a 53-47% margin. Ritz, who defeated our great champion Tony Bennett four years ago, loudly attacked the voucher program and charter schools during her term as Superintendent. These wins, combined with our success in preserving the large majority for educational choice in the state legislature, mean that we enter 2017 with a stronger position than ever before in Indiana.

AFC supported both Holcomb and McCormick directly, but to preserve the strong legislative majority for educational choice, AFC supported Hoosiers for Quality Education PAC, our local allied partner.

#### Louisiana

When the state legislature agreed to transfer governance for New Orleans charter schools and the open enrollment choice system back to the Orleans Parish School Board earlier this year, it created serious concern among education reformers about preserving the interests of charter school students and parents. Therefore, we engaged in the school board campaigns, and we are pleased to report that all seven board seats in Orleans Parish are now filled by reformers. This was a stunning and unexpected defeat for the education establishment and creates hope for the future of schools in New Orleans.

#### Nevada

Nevada was our one electoral disappointment in which AFC had a significant direct investment of resources. With a razor-thin Republican legislative majority in both houses of the state legislature, and multiple races that remained toss-ups right through Election Day, we had to run the table to preserve the legislative majority for educational choice here. This state bucked the national trends and went decisively Democratic, aided by a surge among Latino voters, as well as the turnout machine of outgoing Sen. Harry Reid, who was heavily invested in efforts to see the Democratic candidate hold his seat.

Therefore, control of both legislative chambers of the legislatures shifted from Republican to Democrat, meaning that the anti-educational choice Democratic legislative leaders will now drive the agenda in the state, despite support for choice among some rank-and-file Democratic

members and Democratic parents. This will make protecting charter schools and replacing the funding mechanism for the Nevada Education Savings Account (ESA) program much more difficult. Governor Brian Sandoval (R) has said he will prioritize the ESA in his budget.

#### **North Carolina**

Educational choice supporter Gov. Pat McCrory (R) is currently trailing state Attorney General Roy Cooper (D) in a gubernatorial race that has not yet been called, due to the fact that Cooper leads McCrory by around 4,000 votes out of over 5 million cast — a margin of less than one-tenth of 1%, triggering a recount.

Local allies assure us that a potential McCrory loss will be mitigated because of the charter reforms that have been passed and the important 10-year funding increase for the voucher program that was locked in last legislative session. Furthermore, the North Carolina constitution requires only a 3/5 majority for any override of any future gubernatorial veto, a threshold which is realistically achievable considering the strong school choice majority in the legislature.

One bright spot is that a new Superintendent of Public Instruction, Mark Johnson, was elected, ousting the incumbent Superintendent, an opponent of choice. Johnson is a Teach for America alumnus and an ally.

AFC supported the political efforts of our allied state partner organization in North Carolina, which targeted most of its election investments toward preserving a legislative majority for education reform.

# Ohio

While AFC does not engage in election activity in Ohio, Republicans gained seats in the General Assembly and our two biggest legislative champions switched chambers – switching from House to Senate and vice versa – giving us more leaders who will prioritize school choice legislation.

#### Oklahoma

Opponents in Oklahoma chose to make this year's primary and general elections a litmus test on parental choice issues. It backfired as we beat their state legislative candidates soundly in the primary and ran the table in the general election races. These efforts create the perfect narrative and momentum leading into next year's legislative session to enact robust ESA legislation and expand charter schools.

### Wisconsin

# Other States of Interest in which AFC did not invest

**New Hampshire** —New Hampshire has a very small means-tested scholarship tax credit program, and 2016 election results present a serious opportunity to expand that program. Voters elected Chris Sununu as governor and flipped control of both houses of the legislature into Republican hands.

**Iowa** — While we were disappointed to see our biggest Democratic champion in the legislature lose his seat, the Iowa Senate went strongly Republican and enactment of a large-scale ESA program appears very possible. The House has already passed legislation, Governor Terry Branstad (R) supports it, and 100% of the returning Republican Senators support the legislation.

**Kentucky** – Kentucky was one of the last states in the South to go Republican for its state legislature, and on Tuesday it went strongly that direction. There is now there is a supportive Governor (Republican Matt Bevin), House, and Senate for parental choice. It was possible before that school choice legislation could be passed with a Democratic House, but with a Republican House, chances are better than ever for both meaningful private choice and charter legislation.

**Missouri** – The Missouri legislature has repeatedly passed educational choice legislation in a bipartisan manner only to see it vetoed by the outgoing Democratic Governor. However, school supporter Eric Greitens (R) was elected to the open gubernatorial seat, creating a great opportunity to pass charter school and private choice legislation next session.
