"A series of amendments put forward by house Democrats to increase accountability failed, including one by Hakeem that would have required annual audits for private schools that enroll grant recipients. Hakeem's concern, he said, was ensuring small private schools don't pop up and end up closing within a few years, leaving students high and dry. Two Republicans who later voted against the bill -- state Rep. Jody Barrett, of Dickson, and state Rep. Monty Fritts, of Kingston -- joined Democrats in voting against tabling the amendment. 'Every school that would move forward to educate our children do not have the best intentions, and what we're asking is reasonable accountability,' Hakeem said. **Barrett Complained Not Being Given Time To Oppose The Bill In A Speech On The Floor.** "Republican Rep. Jody Barrett (R-Dickson) has also openly opposed Gov. Lee's voucher plan based on feedback from his constituents and the fiscal analysis, which he said isn't fiscally conservative. Rep. Barrett told News 2 that just two of the 20-something Republicans who voted against the bill were given a total of four minutes to debate it on the House floor, and he wasn't one of them. 'The rules that were put in place were really not designed to provide for any type of banter back and forth,' Rep. Barrett said. 'Essentially what we got was an infomercial where one side got 45 minutes to give their spiel about what they did not like about the bill, and the other side got 45 minutes to give their sales pitch as to why it was a good idea. Dividing 45 minutes among 24 [Democrats] is a lot easier than dividing it among 75 [Republicans].'" As a result, health insurers are forced to only offer costly plans loaded with coverages that most individuals do not need. 




