The Navarro County Republican Party meeting has provided Hunt with an early platform to introduce himself to voters in the region, and having his message heard. Local Republican leaders said his appearance reflects the growing momentum among candidates ahead of the upcoming election season.

With his campaign officially underway, Hunt is expected to continue reaching out to Republicans across the district as he builds support for his vote.

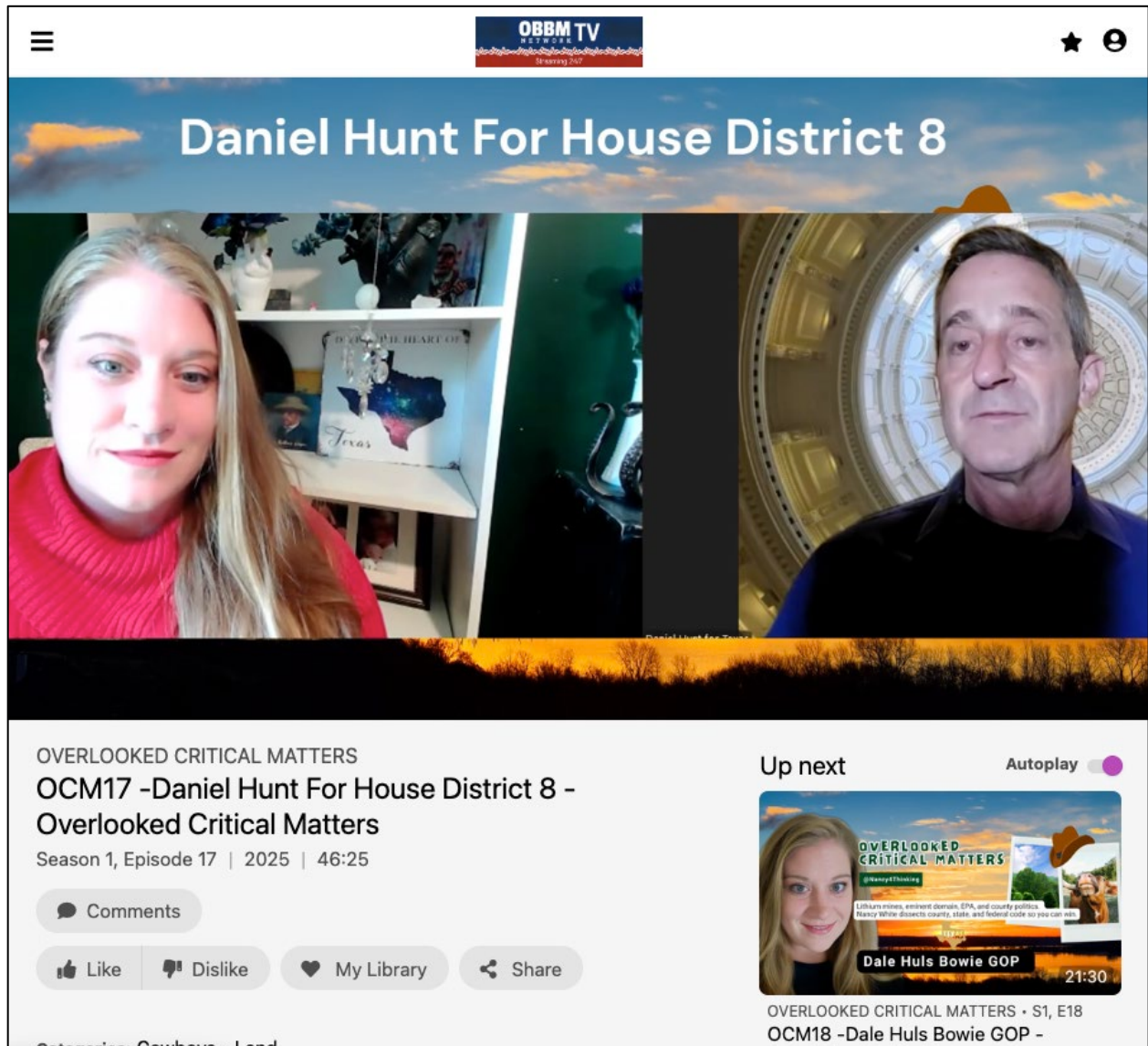
About Me
