## Haynes visits Dalhart, takes on Smithee for House seat

Jamie Haynes made a quick campaign stop at The Flying Pig Mercantile, Coffee and Tea Bar in Dalhart Monday morning. The conservative Republican is running against longtime incumbent John T. Smithee to be Texas House District 86th Representative. Smithee has held the position since 1984.

"I ran smack-dab into the government, and decided to take the matter upstream," Haynes explained her decision to run for office. "I was concerned that Texas was not going to be for our children what it was for us."

Haynes grew up in Brady, and her parents and heart are still there, she said. She now resides between Amarillo and Canyon with her husband and two sons. Haynes is campaigning on four core planks: "Secure the border - The State of Texas needs to take hard action now to legalize and adequately fund border security to defend its citizens.

Protect local control - We must stop the unfunded mandates and restore power to local governments who are more connected with the community.

Elevate education and protect Texas children - We must return to basics, protect parental rights, strengthen the family, give teachers a raise, outline effective enforcement and protect Texas children from sexually explicit materials and harmful Diversity, Equity and Inclusion and Critical Race Theory materials.

Term limits for every Texas politician - We must enact term limits on every Texas politician to eliminate corruption and ensure fresh, new ideas are being heard in the legislature."

"We've got to stop the invasion," she said of the border issue. She spoke of two recent trips to the Texas-Mexico border and the differences between what she termed "Abbott's fence" and "Trump's wall," saying that the whole area is "really a mess. With either one of them, you can literally just find a spot where it ends and go around it," she said.

Haynes also elaborated on school funding saying that, as much as she is in favor of school choice, especially for home schooling, she believes in funding Texas public schools first.

"I very much believe that we need to take care of Texas public education," Haynes said. "We should never put the government in the position to pick winners and losers," which is what a school choice voucher bill would do since so few private school students would be funded. "As a conservative, I never believe in growing government; I think we should try to keep it as small as possible," she continued. "School choice bills would be growing the government."

"I was taught to take care of what we've got, because that's all there is," she added. "We need to move back to the basics."

The primary election will be held March 5, 2024.

“So I am against ESAs or vouchers. I feel like, as conservatives, our job is to limit government in any way that you slice it. ESA and vouchers are expanding government reach. I feel like it's going to harm our small, rural districts. The whole community is surrounded around the school. I my passion has been this whole time that I've inserted myself into Texas politics and taking care of what we've got. We need to empower our educators. We need to make things better. I'm going to stand for taking care of our teachers. This is the next generation of Texas. We have got to make sure, sorry, I have a little more time. We've got to make sure that these students are empowered, that they're educated, and that the role of an educator is something that everybody wants to become, and I feel like it is dwindled down now we've made it so difficult for them. They're stressed out, and they can't even have they can't even hire enough folks throughout the state. We have to empower educators. We need to pay them more, so that way they have a larger pool to pull from, and we have the absolute best in the classroom with our teachers.

**Haynes supported the failed 2024 attempt to turn Amarillo into a “sanctuary city for the unborn.” Proposition A, which among other things would make it illegal to send or possess abortion inducing drugs within or through Amarillo and hold the civilly liable, lost by a wide margin.**

- ◆ In the November 2024 election, voters in Amarillo voted on Prop A which declared the city a “sanctuary city for the unborn.”

**Overview:**

In short: If the majority of voters vote yes, this proposition would allow anyone to bring a civil suit against someone who they think helped or intends to help an Amarillo citizen travel from Amarillo (where abortion is already illegal) to another state where abortion is legal for the purpose of obtaining an elective abortion. The civil suit must be for at least \$10,000, and the burden of proof for the defense is on the defendant.

The Findings portion declares that the City Council of Amarillo finds that human life begins at conception, claims that Texan men and women are being traumatized by abortion in New Mexico and discusses the services provided by the state-wide Alternatives to Abortion program, which was renamed to Thriving Texas Families in 2023. It cites the 2022 Supreme Court decision in Dobbs v Jackson Women’s Health Organization, which essentially overturned Roe v Wade, and the Racketeer Influenced and Corrupt Organization Act (RICO) of 1970, which provides criminal penalties against organizations with a pattern of dealing in controlled substances across state lines.

The Declarations portion declares Amarillo a sanctuary city for the unborn, that abortion is an unlawful act and calls upon United States Attorneys to investigate and prosecute abortion providers under RICO.

Section 1 provides some key definitions. According to the ordinance:

An abortion is an act with the purpose to terminate the pregnancy of a woman. The ordinance also defines a woman as somebody with XX chromosomes and a uterus, regardless of their gender identity.

Abortion-inducing drugs include mifepristone and misoprostol, not contraceptive medication.

Conduct that aids or abets an elective abortion includes but is not limited to providing transportation to or from an abortion provider; giving instructions about self-administering or managing an abortion or obtaining an elective abortion, regardless of where the person giving the instructions resides; offering money or resources with the knowledge that they will be used to enable somebody to obtain an abortion; providing money or resources to an abortion provider or abortion fund; providing insurance that would cover an elective abortion; providing referrals to an abortion provider; and coercing a pregnant woman to have an abortion against her will.

An elective abortion is an abortion that is not performed in response to a medical emergency.

A medical emergency is a life-threatening medical emergency caused by a pregnancy and places a pregnant woman in danger of death or serious risk of impairment to bodily function unless an abortion is performed.

Section 2 establishes that it is unlawful to procure or perform an elective abortion at any stage of pregnancy within the City of Amarillo. Elective abortions are already unlawful at the state level.

Section 3 prohibits abortions on any resident of the City of Amarillo, even if the Amarilloan obtains the abortion in a state where it is legal. If an Amarilloan travels to a state where abortion is legal and elects to have an abortion, anybody who can be perceived as having helped them is open to a civil suit of no less than \$10,000 and would have to prove that they did not help or attempt to help the person who obtained a legal elective abortion.

Section 4 prohibits the abortion “trafficking” of a fetus by declaring it unlawful for a pregnant person to travel through the City limits on their way to seek a legal abortion.

Section 5 declares that it shall be unlawful to possess, manufacture or distribute abortion-inducing medication in Amarillo and to mail or otherwise deliver this medication to Amarillo.

Section 6 declares organizations that send abortion-inducing medications by mail to be criminal organizations.

Section 7 declares it unlawful to transport the remains of a fetus that was terminated by an elective abortion to Amarillo or to dispose of those remains in Amarillo.

Section 8 provides the right to private action (establishes the basis of a civil lawsuit.) According to the ordinance, a person who terminates their pregnancy through an elective abortion cannot be sued, but anybody who helped them may. If successful, the court will award the plaintiff an injunctive relief (a court order to cease the unlawful activity), compensation for damages including emotional distress, statutory damages of at least \$10,000, and costs and attorney's fees.

The ordinance allows plaintiffs to file suit up to the sixth anniversary of the action. It also says that reliance on a law or statute that has since been repealed or declared invalid is not a valid defense.

City Attorney Bryan McWilliams said in an email to the Amarillo Tribune, "Per Section 8-6-8 (k) of the proposed ordinance, 'a civil action under this section may be brought only in the district courts of the state of Texas and may not be considered by any municipal or county court.'"

The only affirmative defenses are for the defendant to prove that they were unaware that they were engaged in such conduct and that they took every reasonable precaution to ensure they did not violate the ordinance.

This suit cannot be brought against a common carrier (such as Greyhound) or the person who obtained an elective abortion. It cannot be brought by a person who impregnated an elective abortion recipient through rape, sexual assault or incest.

McWilliams said that City officials have no role in the enforcement of this ordinance.

Background: On July 13, 2023, Mark Lee Dickson held an interest meeting at Trinity Fellowship Church, proposing that Amarillo pass the Sanctuary City for the Unborn Ordinance. Dickson, who is not an Amarillo citizen, founded the Sanctuary Cities for the Unborn Initiative.

As reported by Julie Thompson of The Amarillo Tribune, the Amarillo City Council held a discussion on the Sanctuary City for the Unborn ordinance on Oct. 24, 2023.

On May 16, the city announced that a petition for a proposed Sanctuary City ordinance was submitted in April and garnered more than 10,000 signatures and approximately 6,500 of them validated by the City Secretary, which prompted the city council to vote on the matter.

The council voted down the ordinances on June 11. The Initiating Committee then requested that the ordinance be put to a city vote. The council called for a special election – including the city charter amendment propositions (Propositions B-E) – on Aug. 13 and finalized the ballot language for Proposition A on Sept. 10.

According to the Amarillo Tribune’s best analysis of financial documents we received through a FOIA, as of Sept. 20, the City of Amarillo paid \$18,006.50 to Hyde Kelley LLP for its work on researching the Sanctuary City for the Unborn Ordinance’s legality and ballot language billed through July 31.

According to the agenda item summary for the Aug. 13 city council meeting when they called for the special election on Nov. 5, the election is estimated to cost between \$100,000 and \$150,000. This estimate is for the entire special election, including the charter amendment election.

The ballot language for Proposition A will read as follows:

The Code of Ordinances of the City of Amarillo, Texas shall be amended to adopt an initiated ordinance, submitted by the Amarillo Sanctuary City for the Unborn Citizen Initiative Petition Initiating Committee, declaring the City of Amarillo a sanctuary city for the unborn, declaring that abortion at all times and at all stages of pregnancy is unlawful unless and abortion is performed to save the life of a pregnant woman in a medical emergency, finding that abortion-inducing drugs are declared contraband and it shall be unlawful for any person to manufacture, possess, or distribute abortion-inducing drugs in the City of Amarillo; prohibiting abortions within the City of Amarillo, prohibiting abortions on City of Amarillo residents; prohibiting abortion trafficking of an unborn child, prohibiting abortion-inducing drugs in the City of Amarillo, prohibiting any organization that violates 18 U.S.C. Sections 1461 or 1462 by facilitating abortions from operating or doing business in the City of Amarillo; prohibiting the transportation or disposal in the City of Amarillo of the remains for an unborn child killed by an abortion; providing a private right of action; providing for affirmative defenses; providing for severability and providing an effective date.







◆ “Haynes: ‘I Don’t Regret’ Being a Member of Amarillo Matters (*The Amarillo Pioneer*, 02/05/2024)

During The Amarillo Pioneer’s 2024 Primary Election forum, State House District 86 candidate Jamie Haynes was asked about her past affiliation with Amarillo Matters, a group which has earned the ire of many local conservatives. Below is a transcription of the answer given by Haynes:

“Okay, first of all, I am a conservative and when I started paying attention to Texas politics, which I really did not a lot, I always voted of course conservatively, always voted Republican, but I wanted to learn. I am a big believer in learning everything I possibly could and I heard about this group in town that was trying to make Amarillo a better place and I understood that they were going to get really involved in school elections and so that really interested me I wanted to learn more. These were Community businessmen, leaders that I had known. The main gentleman that was in charge was previously my Sunday school teacher. And so I said absolutely I want to get in this group and so I did. I joined, they asked me I said yes and I was in for about 11 months I realized about that time that there were other things calling me and that was everything that was going on with the Republican party and these coalitions I felt very led to devote more of my time to that. It was very consuming trying to travel back and down back and forth to Austin until I left that group. I said thank you guys so much I just feel led over here. Did we agree on everything? We did not. Did I voice my opinion a lot? I did not. I was just sitting there kind of listening, learning. It was very interesting. It was a good experience. I don't regret it. a lot of those

men and there were a couple of women that came and went are our Leaders in our community and do a lot of great things for our community. So, I don't want to downplay that group or be negative towards that group in any way. If I were to do it all over again I would still join them. I learned and but I feel led to do, to spend my time in different areas. To focus on children, focus on Texas."

## Haynes refused to say that transgenderism is a mental illness.

- ◆ During a March 2025 podcast appearance, which mostly discussed Haynes being disciplined by the Realtors for speaking up against sexually explicit books at the Canyon ISD school board meetings, the host asked if Haynes thought transgender people were mentally ill. Haynes only responded that “I do not hate anyone in this world.”

The Commission would be tasked with promoting religious freedom, identifying challenges and solutions related to religious liberty, and serving as an advisor to the Governor on religious freedom issues including making recommendations regarding local and state policies that violate or fail to ensure an individual's right to


### Our Happy Union




